## CORPORATE PROFILE

AmFIRST REIT is one of the largest Malaysian-based commercial REITs and owns a diverse portfolio of nine (9) properties strategically located within KL City Centre, Petaling Jaya, Subang Jaya, Cyberjaya, Melaka and Penang.

## SALIENT FEATURES

### Investment Objective

To own and invest in real estate and real estate related assets, whether directly or indirectly, through the ownership of single-purpose companies whose principal assets comprise of real estate and real estate-related assets.

### Distribution Policy

Income distributions will be paid on a semi-annual basis (or such other intervals as determined by the Manager).

The Manager intends to distribute at least 90% of the distributable income for each financial year.

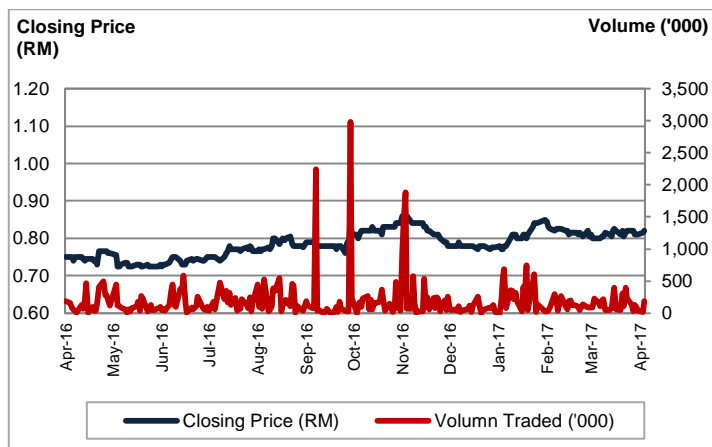

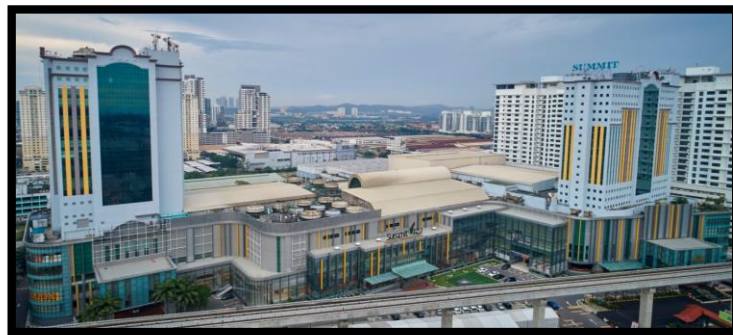
