The Malaysian real estate investment trust (M-REIT) industry kicked off the past decade with a bang. It saw rapid growth in the first half of that 10 years, with its market capitalization almost quadrupling from RM9 billion in 2010 to RM38 billion as at 31 March 2022. With 18 listed real estate investment trusts (REITs) in Malaysia, REITs have become a significant component of the listed capital markets.

Malaysia's REIT industry has provided investment diversification, stakeholders income stability, inflation protection, delivering long-term performance of lower risk and volatility. M-REITs saw a landmark development with the launch of the Bursa Malaysia REIT Index in October 2017, increasing the visibility of M-REITs in the capital market.
